### **Finance Committee Update**

 As a brief review, Adam noted that 62% of the total amount of money pledged has been received, and a comparable percentage of budgeted expenses have been posted, both of which are in alignment with the proportion of the fiscal year that has lapsed since its start in July 2021 • Moreover, no additional major expenditures are planned for the rest of the fiscal year, since all renovation work (including the curtaining of the sanctuary windows) has been completed, most of whose cost has already been accounted for

## Stewardship Drive

#### **Description:**

• The annual stewardship drive begins in March. The UUCS Board needs to identify a team that will lead this effort.

#### Goals:

- Identify the stewardship drive team and secure commitments from them.
- Support the stewardship team as requested

#### Minutes:

- Bonnie Lepoff agreed to serve as the lead for this year's UUCS stewardship drive, with support from Jackie Mills. A replacement to handle next year's drive needs to be identified now so that this person can play a role during this year's drive
- This year's stewardship drive will be conducted with a limited level of interventions, due to Covid fatigue
  - Letters, brochures, and follow-up calls will be the main means of communication, while neither dinners nor mass zoom meetings will be held
  - The theme for the drive is "Draw the Circle Wide," which is also reflected in our hymn of the month, the Soul-Matters topics, and serves to be an inclusive goal for the drive.
  - Related activities planned for this year's stewardship drive by UUCS:
    - Church membership list will need to be reviewed and updated ("scrubbed")
    - Pledge request letters, as well as related brochures and slide deck presentations, will need to be prepared
    - Pledge web page will need to be rebuilt with Jenny's assistance
    - Individual members to be found for giving Sunday testimonials, which will be videorecorded
    - Dates for Ministry Minutes to be selected
    - The target for the pledge drive is \$218,000, which is an increase of ~12% over last year.
    - Stewardship drive kickoff slated for Sunday service announcement on March 6th
- Scheduling of UUCS Town Hall meeting was proposed for either March 13th or 20th, at which Board members should be present. These dates potentially conflicted with availability of Rev. Aileen, and a finalized date to be set shortly

• Mark introduced the suggestion that had been raised by a UUCS church member of hiring a membership consultant. He asked the membership team to look into this as a possible option and bring their recommendation to the board along with their rationale.

## Next Year's Board

#### Description:

• Many of the Board members will drop off at the end of the year. Mark, Steve, and Jack were appointed (not elected) to their positions, and so need affirmation from the congregation as part of the annual congregational voting for the board if they want to remain. Sharon and Susan are completing their second year on the Board. We need to provide support to the nominating committee.

#### Goals:

- Understand the intentions of current Board members to stay on for the next year (July 2022 June 2023).
- Support the Nominating Committee with identifying potential board members for next year.

#### Minutes:

- For next year, Mark agreed to serve as Board President and Jack agreed to serve as Board Secretary. Since both were previously appointed by the board (in lieu of elected during the annual meeting), will need to be elected during the annual meeting; Adam will continue as Board Treasurer.
- Steve had previously updated the position descriptions of the UUCS Board, to include atlarge member position descriptions and an update to the treasurer position that includes a requirement to conduct an in-house audit of the financial records every other year (instead of yearly).
  - We discussed whether to formally add in the requirement for the vice president to lead the annual stewardship drive. It was previously an unwritten expectation that fell away years ago. Similarly, there was an expectation of the vice president serving as president the following term. We will discuss this further when looking at the descriptions more critically next month
  - We also clarified the role of the Secretary who will collaborate with the Administrator in the review of the listing of UUCS church members, so that the roster's content for accuracy and completeness is "preserved"
- The board approved the updated position descriptions that will now be voted on as changes to the by-laws during the annual meeting.
